

SHOW RULES OF THE ALABAMA GUN COLLECTORS ASSOCIATION

The Board of Directors of the AGCA hopes that each one attending this gun collectors event will have an enjoyable time and also solicits your thoughts and suggestions for bettering our shows.

The General Business Meeting of A.G.C.A. will be at 8:30 a.m. on Sunday, October 12, 2025.

The A.G.C.A. does not insure the safety of any article brought on the show premises for any purpose. Security provided by the A.G.C.A. on the show premises is done solely to preserve public order and for the convenience of the A.G.C.A. exhibitors and the general public. Anyone bringing items on the show premises does so at his own risk.

SAFETY FIRST

NO LOADED FIREARMS AT ANY TIME .

THE ACTION OF ALL GUNS MUST BE SECURED IN A NON-FIRABLE CONDITION BY A NYLON CABLE TIE AT ALL TIMES. Cable ties are provided free by the AGCA at the check-in table. Any weapon with a removable clip or magazine **MUST** have the **CLIP OR MAGAZINE REMOVED**. This applies to vendors as well as patrons. **EXCEPTIONS: DISPLAY ONLY, MUZZLE-LOADERS AND OR GUNS BROKEN DOWN IN BOX.**

NO LOOSE ROUNDS OF AMMUNITION ALLOWED ON TABLES. All ammo must be boxed or cased. Display-only table may contain belts with ammunition.

GENERAL TABLE RENTAL

1. **Table rental** must be paid before occupying table. No transfer of tables will be allowed. Absolutely **no purchasing of tables for others.**
2. **Tables not occupied by 10:00 a.m. Saturday** will be reassigned as needed unless late arrival is confirmed.
3. **All table holders and assistants on tables must wear a proper name badge** at all times. Regardless of the number of tables he/she has rented, each confirmed table holder will be issued free badges for nonmember table assistants as follows: total of two badges for trade tables or one for display tables. Members wear membership badges. Assistants' badges can be picked up only by the confirmed table holder. (Identification may be required!) Extra assistant badges may be purchased by the confirmed table holder for \$10.00 each.
4. Each **table holder is responsible for any and all actions of those people assigned to his/her tables.**
5. Anyone **under 18 years of age** must be accompanied by an adult at all times.
6. Any person buying, selling, trading, otherwise disposing or, or acquiring items at this show must do so in compliance with **local, state and federal laws** and also in compliance with the **AGCA Constitution and By-laws.**
7. **No alcoholic beverages** of any kind are permitted in the AGCA exhibition hall at any time.
8. **No pets** allowed in the exhibition hall except service animals with proper certification.
9. **No two-way radio usage** except by show officials and police.

DISPLAY TABLES

1. **NO SALES ARE ALLOWED FROM DISPLAY ONLY TABLES.**
2. Display table holders must register their display at the check-in table before 11:00 a.m. on Saturday of the show in order for it to be JUDGED. Displays may be registered in the table holder's name only. Registration forms must be completed in their entirety and LEGIBLE. Incomplete or illegible forms will be grounds for disqualification.

PROHIBITED ITEMS

ALL tables must contain guns, edged weapons or related items.

The following items are PROHIBITED on tables:

1. **Any items** that the possession or sale of which is prohibited by federal, state or local law.
2. **Any items that are not guns, edged weapons or related items, except that up to 15% of a table may be used for other items of general collectible interest.**
3. Books, videos or other **materials related to bomb/explosive making, booby-traps, how to kill or similar topics.**
4. **Items that may present a public safety hazard**, such as laser pointers, ninja stars (etc), chemical disablers, tasers or pyrotechnics.
5. **Class 3 weapons** may be shown only by AGCA members on a properly marked DISPLAY ONLY table.

During the show, all tables will be periodically monitored by AGCA officials who can be readily identified by badges they wear. Rules violators will be given an official warning to remove prohibited items from tables. Failure to do so or to abide by these rules and the rules as set forth in the Constitution and By-laws of the Alabama Gun Collectors Association will be cause for immediate expulsion from the premises, forfeiture of table rent, and/or suspension of AGCA membership.

Show Management reserves the right of final decision relating to questionable items or exhibits.



CLARIFIED RULES: Beginning with the October 2020 show, AGCA will only roll tables over **ONCE** and only due to an emergency; not a scheduling conflict. Additionally, if you are unable to attend a show and have registered for a table and do not notify the AGCA that you will not be in attendance, you forfeit your table fee and possibly the guarantee of your current table location. Lastly, after the October 2020 show, all one-day table holders will be placed closer to the back of the hall (regardless of your current location) in an effort to not leave empty spaces up front for Sunday patrons.

NOTE: Load in on Saturday will be through the BACK, ROLL UP DOORS ONLY. If you can hand carry items in, you will be allowed to enter through the front/sides. NO CARTS, WAGONS, ETC OF ANY KIND WILL BE ALLOWED THROUGH THE FRONT/SIDE DOORS ON SATURDAY REGARDLESS IF THEY FIT THROUGH THE SINGLE DOOR.
